# **Orientation paper and upcoming Call for Proposals**

The Health Orientation paper prepared in connection with the FP7 2013 Work Programme in the area of Health research was published at the beginning of April on the Participant Portal. Please note that this paper has been made public at an early stage and, as such, it is a working document not yet endorsed by the Commission. The official Work programme for Health is **expected to be published on 10 July 2012** on the Participant Portal.

Two health calls are proposed, following the two-stage procedure:

**FP7-HEALTH-2013-INNOVATION-1** is the main call with many broad, bottom-up SMEand/or industry-relevant topics. Those topics are set out in areas of great interest to SMEs such as medical technologies, where a certain proportion of the EU requested contribution - as a minimum - has to go to SMEs.

**FP7-HEALTH-2012-INNOVATION-2** with 2 topics and an indicative deadline on 25th September 2012.

FP7-HEALTH-2012-INNOVATION-2 is a specific call with the aim of boosting SME participation for innovative solutions in the health sector. The requirements of this call are very specific; the detailed guidelines will be published together with the official call.

The research priorities for 2013 are: brain research, antimicrobial drug resistance and comparative effectiveness research, complemented by topics from other areas such as approaches for developing personalised medicines, cardiovascular research, the safety and efficacy of therapies, cancer and public health research and a horizontal activity for translating research results into innovative applications for health.

### **IMI** Calls for Proposals



#### 6th call : Combating Antimicrobial Resistance - NewDrugs4BadBugs (ND4BB)

IMI's 6th Call for proposals was launched on 24th May 2012 which consists of one theme: Combating Antibiotic Resistance - NewDrugs4BadBugs (ND4BB). Antimicrobial resistance is a major public health threat. With this topic IMI contributes to the European Commission's action plan on antimicrobial resistance. The Call comprises two topics:

•Topic 1 is on innovative trial design and clinical drug development and is broken down into two subtopics (1A and 1B).

•Topic 2 is on 'learning from success and failure and getting drugs into bad bugs'.
